Bids bond must be valid for a period of 120 days after bid opening and must be accompanied by a Original copy of the bid security in. amounting to a minimum of **NRs. 125,000.00**, (Equivalent amount in bid currency at selling exchange rate published by Nepal Rastra Bank on bid notice publication date) which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
