The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00, 23rd Kartik, 2078 atthe Office of the Municipal Executive, Namobuddha Municipality, Bhakundebeshi Kavrepalanchok. Bids bond must be valid for a period of 120 days after bid opening and must be accompanied by a Original copy of the bid security in. amounting to a minimum of *NRs. 140,000.00*, (Equivalent amount in bid currency at selling exchange rate published by Nepal Rastra Bank on bid notice publication date) which shall be valid for 45 days beyond the validityperiod of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall beconsidered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 7. All the procurement procedures will be carried out under Public Procurement Act, 2007, Public Procurement Regulation, 2007, Financial Procedure Act, 1999 and Financial Procedure Regulation, 2007.
